## **Environmental Scan Defined**

*Historically used as a business management technique by which a business gathered environmental information for a competitive edge.*

- ✓ Scanning is a process for identifying & assessing factors that shape the environment
- ✓ Data provides insight into the potential challenges and opportunities an organization may face and into the strategies needed to overcome/succeed
- ✓ Critical in the planning process
- ✓ Helps and organization understand how a changing world can impact the ability to realize the organization's vision/mission

## Scanning Versus SWOT Analysis

- ✓ Environmental Scan = collecting information and data to gain understanding
- ✓ SWOT analysis = placing this information into categories to take action
- ✓ Information and trends discovered during the Environmental Scan process can provide the foundation for a SWOT Analysis finding.
- ✓ For example, if the Environmental Scan predicts that there will be a shortage of trained counselors, this shortage would likely be identified as a Threat in the SWOT Analysis.

## Scanning Versus SWOT Analysis

- ✓ Strengths and weaknesses tend to be associated with the internal environment, or the situation inside the organization (operations, performance quality, infrastructure, governance, etc.).
  - *These also tend to be in the present.*
- ✓ Opportunities and threats, therefore, relate to the external environment – the situation outside of the organization.
  - *These tend to be posited in the future (competition, trends, political landscape, etc.).*

## Five Future Spheres

*Provide a format for organizing information into groupings*

<b>Econosphere</b>	Gross national product, inflation/deflation, financial markets, prosperity/decline, unemployment, etc.
<b>Sociosphere</b>	Lifestyles, consumer activism, education, career expectations, demographics, values, role models, mass communications, population growth/decline, family formation, population shifts, family stability, life expectancy, birth rates, literacy, crime/drugs, etc.
<b>Technosphere</b>	Automation, productivity, new products, laboratory to market transfer, federal research and development, direction of technology development, patents, international technology transfer, etc.

## Five Future Spheres

*Provide a format for organizing information into groupings*

<b>Politisphere</b>	Political alignments at the national, state and local levels, the justice system, environmental protection, tax laws, laws on hiring, discrimination, pay, foreign trade regulations, government stability, federal/state balance, international political conditions, etc.
<b>Biosphere</b>	Conditions in the natural environment that place limitations on an organization's freedom of action: pollution; depletion of natural resources, deforestation, global warming; threats to endangered species; erosion of farm land; salinization of rivers, etc.

## Basics of the Scan

1. Identify participants and responsibilities
1. Conduct scanning activities
  - ✓ *Five spheres*
  - ✓ *Competitors*
  - ✓ *Organization (now and future)*
2. Identify and analyze important issues and trends
3. Report results or select issues and trends to act on
4. Scan on a continuous basis
